

# JETCO Mail-in Contribution Form for TAX YEAR 2018 3 Easy Steps

**STEP 1:** Pay by credit card or write a check for up **to \$1,107 (\$2,213** for married couples filing jointly). Any amount of your tax credit that exceeds your tax liability can be carried forward up to five years.

**STEP 2**: Complete this form and place your check or credit card information in the envelope and mail it today to **JETCO, 3718 E. River Rd., Ste. 100, Tucson, AZ 85718**. Or make your contribution directly online at www.jetco.org.

**STEP 3:** Claim your dollar-for-dollar tax credits on your Arizona income tax return.

The maximum credit that may be taken for the "Switcher" credit is \$552 (\$1,103 for married filing jointly)
